While this manual contains information to assure safe and enjoyable boating, it does not provide everything you need to know. Above all take time to know your boat and its new equipment.

OWNER'S MANUAL STRUCTURE

Use your Owner's Manual as a guide to familiarize yourself with the operation and components of your Slide-In Handles. The procedures in this manual will assist you with safe and proper installation, operation, and maintenance of your product. The level of information may be general in some cases and more detailed in others. Your owner's manual is designed with the boat owner/operator in mind.

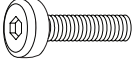

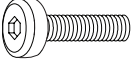

PRE-INSTALLATION

The photographs provided allow for easier assembly when used in conjunction with the assembly instructions.

- Remove all parts and hardware from box and lay out on a carpeted or scratch-free work surface, as this will avoid damaging any parts during assembly. The shipping box provides an ideal work surface. Do not dispose of any contents until assembly is completed to avoid accidentally discarding small parts or hardware.
- Save all packing materials until assembly is complete to avoid accidentally discarding smaller parts or hardware.
- Use the parts and hardware lists to identify and separate each of the pieces included prior to starting assembly.
- Note: DO not fully tighten all bolts until all parts are in place. Failure to follow these instructions may cause the bolts to misalign during assembly.
- If using power tools to aid in assembly please use caution. Power tools can damage hardware.

INSTALLATION INSTRUCTIONS

1. The top tube of your current swim ladder must measure 1.25" or 1.5" in outside diameter.
2. Unscrew the nuts that secure your ladder's pivot bolt to the tube. Remove the pivot bolt(s) that go through your ladder's tube top in order to remove the plastic caps.

Note: We recommend using a flat head screwdriver to remove the ladder caps. Insert the flat blade of the screwdriver under the cap rim and use leverage to unplug the cap (Fig. 1).

3. Remove the plastic cap plugs from the top of the ladder tube on both sides. This will expose the inside of your ladder tube (Fig. 2).

4. Install your new hardware by following these steps:

Note: We recommend only removing and replacing the pivot bolts one ladder tube at a time.

- a. Insert two (2) cap screws into the "x" slots on each end of one (1) included installation tab paper (Fig. 3).

Note: We recommend attaching a piece of tape to each washer for an easier, more secure grip as you thread the bolt through (Fig. 4).

- b. Maintaining a firm grip on the ladder tube, insert one (1) washer between the tube and ladder pivot bracket. While holding the washer in place, insert one (1) installation tabbed cap screw through the bracket, washer, and tube. The head of the screw should be inside the tube, threads pointing outward. Repeat on other side of the tube (Fig. 5).

- c. Insert the allen key into the head of one cap screw, applying pressure to secure the screw as you thread on one (1) nut to the outside of the pivot bracket. Start by lightly tightening the nut on by hand. Repeat on other side of tube.
- d. Remove the installation tab paper by pulling upward and tearing the paper away. Remove the tape from the washers.
- e. Tighten the nuts so that the ladder tubes and pivot brackets are snug, but still free to rotate. The threads of the screws should protrude slightly beyond their nuts (Fig. 6).
- f. Repeat steps a - e for other ladder tube.

5. Insert Your Slide-In Handles into the top of each ladder tube. The handle base should slide over the pivot screws and sit snugly into the top ladder tube portion of your ladder (Fig. 7).

Note: There is a left and right handle. Make sure that the warning label with the text “this side toward water” is facing outward toward the water and not toward the boat (Fig. 8).

6. Enjoy! Read and follow all safety information. Remove your handles from the tubes and store your ladder normally when not using the handles for entering or exiting the water.

Please read all instructions carefully before use.

NEVER use ladder when motor is running.

NEVER use ladder for diving or jumping.

NEVER use ladder to board a boat out of the water.

Keep fingers clear of pinch points.

These products are NOT a floatation device.

Overloading this device could damage your boat ladder or result in injury.

Securely stow this device in a safe location when underway.

Do NOT attach tow lines or mooring lines.

Face boat when using ladder and handles.

Neglecting to follow these safety and usage guidelines may result in injury or death. Please boat responsibly and safely.

CARE INSTRUCTIONS:

The following are recommended care instructions to extend the life of your product:

- When not in use, store handles in a cool, dry place and avoid direct sunlight exposure.
- Remove excess water from handles before storage. Remove water with a soft, clean cloth.
- Remove any dirt or debris with a soft, clean cloth and mild cleaning agent.
- We do not recommend the use of chemical cleansers, abrasives, or polish.
